PRIVACY

Your privacy is critically important to us. It is Fund Love's policy to respect your privacy regarding any information we may collect while operating our website.

By using the Site, you agree to accept this Privacy Policy ("Policy") and its terms. We may occasionally need to make changes to our Policy to reflect changes in our site and address new issues. Although most changes are likely to be minor, Fund Love encourages visitors to frequently check this page for any changes to its Policy. Your continued use of our website(s) after any change(s) in this Policy will constitute your acceptance of such change.

1. *What personal information do we collect?*

Fund Love, Inc. ("Fund Love") operates a website at fund-love.org. You may use our site without disclosing personally identifiable information. We do not ask you for personal information unless we truly need it. We want to be clear that we will not obtain such information about you unless you choose to submit to us.

Certain visitors to our website choose to interact with Fund Love in ways that require Fund Love to gather personal information. The amount and type of information that Fund Love gathers depends on the nature of the interaction. For example, we ask visitors who wish to contact us with questions, register for services, or avail themselves of other online services, to provide certain personal information, which may include a username, email address and other information.

Fund Love collects anonymous information of the sort that web browsers and servers typically make available, such as the browser type, language preference, referring site, and the date and time of each visitor request. Our purpose in collecting non-personally identifying information is to better understand how our visitors use the website. From time to time, Fund Love may release non-personally-identifying information in the aggregate, e.g., by publishing a report on trends in the usage of its website.

Fund Love also collects information like Internet Protocol (IP) addresses for logged in users and commenters to profiles published on the website. Fund Love only discloses logged in user and commenter IP addresses under the same circumstances that it uses and discloses personal information as described in this Policy.

Fund Love may collect statistics about the behavior of visitors to its website. For instance, Fund Love may monitor the most popular pages and content on the site or use spam screened by a third party to help identify spammers. FundLove may display this information publicly or provide it to others. However, FundLove does not disclose personal information other than as described in this Policy.

2. *How do we use your personal information?*

Those who engage in transactions with Fund Love are asked to provide additional information, including as necessary the personal information required to process those transactions. In each case, Fund Love collects such information only insofar as is necessary or appropriate to fulfill the purpose of the visitor's interaction with Fund Love.

Fund Love does not collect banking or other financial information and does not disclose personal information other than as described herein.

Visitors can always refuse to supply personal information, with the caveat that it may prevent them from engaging in certain website-related activities.

3. What does it mean for you to give consent?

By using the Site, you consent to the terms of this Policy and to the processing of your personal information as described herein.

By providing us with an e-mail address, you agree that we may use your e-mail address to communicate with you about our services. You can opt-out of receiving e-mails from us at any time simply by using the “unsubscribe” link at the bottom of each email communication.

If you send us a request (for example via a support email or via one of our feedback mechanisms), we reserve the right to publish it in order to help us clarify or respond to your request or to help us support other users. FundLove takes all measures reasonably necessary to protect against the unauthorized access, use, alteration or destruction of potentially personally-identifying and personally-identifying information

If you wish to subscribe to our Newsletter, we collect and store first and last names and e-mail address. This information is used for distribution purposes. If you would like to unsubscribe from our e-mail newsletters, please use the link at the bottom of every e-mail communication or you can e-mail your request at [morethancancer \(at\) gmail \(dot\) com](mailto:morethancancer@gmail.com).

When you register for services or reply to any of our communications with a request, we may need to collect additional personal information. For example, you may be asked to provide personal information, such as demographic information, if you choose to complete any of the online forms or to provide feedback. Additional questions may be included to help us improve the services we offer.

If Fund Love, or substantially all of its assets, were acquired, or in the unlikely event that Fund Love goes out of business or enters bankruptcy, user information would be one of the assets that is transferred or acquired by a third party. You acknowledge that such transfers may occur, and that any acquirer of Fund Love may continue to use your personal information as set forth in this Policy.

4. What circumstances may require additional information or consent from you?

5. When do we share personal data?

We don’t share your personal information with anyone except to comply with the law, develop our services, or protect our rights. Only designated personnel within Fund Love will have access on a need to know basis to the information you provide.

Fund Love may occasionally provide statistics to third parties related to the number of visitors who use the site. These statistics do not provide personally identifiable information.

Fund Love discloses personal information only to those of its employees, contractors, campaign sponsors and affiliated organizations that (i) need to know that information in order to process it on FundLove’s behalf or to provide services available at Fund Love’s websites, and (ii) have agreed not to disclose it to others.

Some of these third party recipients may be located outside of your home country. By using Fund Love’s websites, you consent to the transfer of such information to these third parties.

Fund Love will not rent or sell your personal information to anyone.

Other than as described above, Fund Love discloses personal information only in response to a subpoena, court order or other governmental request, or when Fund Love believes in good faith that disclosure is reasonably necessary to protect the property or rights of Fund Love, third parties or the public at large.

6. *Where do we store and process personal data?*

We do not store your personal information on our servers unless required to do so for the on-going operation of one or more of our services or as otherwise consented to by you.

7. *How do we secure your personal data?*

Fund Love has taken reasonable steps to ensure the integrity and confidentiality of personally identifiable information that you may provide. You should understand, however, that electronic transmissions via the Internet are not necessarily secure from interception and so we cannot guarantee the security or confidentiality of such transmissions.

We use all reasonable efforts to prevent unauthorized access by a secure firewall and use a security infrastructure that protects the integrity and privacy of such personal information. As an additional security measure, your personal information is also encrypted during transmission by Secure Socket Layer 128-bit encryption software. Encryption is a common method used to transmit sensitive data across the Internet. Encryption temporarily makes the text unreadable during the time it is being transmitted over the Internet.

8. *How long do we keep your personal data for?*

Fund Love keeps your personal information only for the length of time reasonably necessary to provide the services requested by you through the site or as otherwise permitted by your consent or by operation of law.

Fund Love collects and saves the default information customarily logged by Internet server software. These logs may be kept for an indefinite amount of time, used at any time and in any way necessary to prevent security breaches and to ensure the integrity of the data on our servers.

Comments and other content submitted via the anti-spam service are saved on our servers unless they were marked as spam positive, in which case we store them long enough to use them to improve the service to avoid future false positives.

9. *Your rights in relation to personal data.*

You have the right at any time to request access to or deletion of your personal information collected by Fund Love, and to withdraw your consent to the processing of your personal information as described in this Policy.

10. *Visitors under the age of 13, those who are California residents, and international users.*

Our site is intended only for users who are 13 years of age and older. Fund Love will not knowingly collect or use any personal information from children that we know to be under the age of 13. If we become aware of personal information that was collected from a child under 13, we will delete such information.

If you are a California resident, California law permits you to request certain information regarding the disclosure of your personal information by us and our related companies to third parties for the

third parties' direct marketing purposes. To make such a request, please send your request by e-mail to at team@fund-love.org.

When our website is used outside of the United States, the user understands and provides consent to the transfer of personal information to, and the collection, processing, and storage of personal information in the United States and elsewhere. The laws in the U.S. and these countries regarding personal information may be different than the laws of your state or country.

11. *Use of automated decision-making and profiling.*

Fund Love does not use profiling or other automated decision-making tools.

We may use Google Analytics, a web analytics service provided by Google, Inc., and other online analytics services on our sites. These analytic services help us analyze how users interact with and use the web site, compile reports on the web site activity, and provide other services related to web site activity and usage. These technologies may use cookies and collect information such as your IP address, time of visit, whether you are a return visitor, any referring website, and other information. We do not use Google Analytics to gather information that personally identifies you. Google's ability to use and share information collected by Google Analytics about your visits to this site is restricted by the Google Analytics Terms of Use and the Google Privacy Policy. You can prevent Google Analytics from recognizing you on return visits to this site by disabling cookies on your browser.

13. *Does Fund Love use “cookies” to collect user information?*

A cookie is a string of information that a website stores on a visitor's computer, and that the visitor's browser provides to the website each time the visitor returns. Fund Love uses cookies to help FundLove identify and track visitors, their usage of the Fund Love website, and their site access preferences.

Like many other websites, Fund Love uses aggregate data compiled by cookies to provide us with information about traffic to our site. Collecting this information does not allow us to personally identify you. Most web browsers automatically accept cookies, but you can set your browser to refuse them or to alert you when they are being sent. You may modify your web browsers to reject cookies from our site if you wish. You can access the information on the Site without having cookies enabled in your browser.

14. *Are there advertisements on FundLove's web site?*

At present, Fund Love does not accept advertisements on its website.

15. *Linking to other websites / third party content.*

Our site may contain links to other websites which are outside our control and are not covered by this Policy (“Third Party Websites”). If you access Third Party Websites using the links provided, the operators of such sites may collect information from you which will be used by them in accordance with their own privacy policies, which may differ from FundLove's. This Policy covers the use of Fund Love's website and does not cover the use of any Third Party Websites.
